Unfortunately there is no prospect of the recently lost 768 and 179 services being restored and there is little prospect of the new 522 service running through Tunley. However a proposal for a new service combining the 768 and the 179 services into a new route is being drawn up to be presented to WECA. It takes several months to restore a lost bus service, so a shorter term solution is being worked on to use the WestLink minibuses for a limited timetabled	

		service to serve Tunley. In conjunction with this work, the campaign work to reinstate lost supported bus services is continuing as well as meetings with the West of England Combined Authority (WECA) as the transport authority and First Bus.
