The flooding may have been made worse by a blockage of trees and farm gates in the Cam Brook on the other side of the A367. The last time this matter was raised with the Environment Agency who were very helpful but the issue could not be resolved due to not being able to identify one of the owners of the land on the side of the stream. As the site is in their parish the parish council to write to Combe Hay parish council asking if they know who the relevant landowner is. 8	NEW ISSUES RAISED BY COUNCILLORS/PARISH	IIONERS	
8.1	Consideration of the Future of the A367 Dunkerton Bus Shelter Street Light	In March 2023 the Dunkerton Bus Shelter faulty light that the parish council owns was reported to us via Fix My Street and raised directly with us in August of that year. The clerk spent over 9 months chasing Volker (BANES highways and street light repair contractor) to get a quote for the repair to no avail despite the intervention of BANES street lighting team. Therefore the parish council decided not to proceed with the repair and only look again at this issue when we received another complaint. The parish council has now received a follow up complaint that the street light has not been repaired yet. The clerk has replied to the complainant explaining why the street light has not been repaired and has heard nothing further since.	Clerk

		It has been proposed by Cllr Robinson that the parish council contact BANES with a brief history of the matter. And then go on to state that it is an absurd situation that a small rural parish, with limited funding, should continue to be responsible for one isolated light on this major trunk road, and that we are no longer prepared to be responsible for this light. It was unanimously resolved that the clerk would write to BANES, pointing out that BANES' adoption of the lighting on the A367 would make sense within their large and important "Somer Valley Links" transport strategy.
